**Subject:** ***Hospital Quality Reporting Secure Portal Now Open for Submission of 2Q 2021 PC-01 Data***

The purpose of this email is to notify hospitals participating in the Inpatient Quality Reporting (IQR) Program that the submission period for second quarter (2Q) 2021 Perinatal Care Elective Delivery Measure (PC-01) is **October 1-November 15, 2021**.

Eligible IQR hospitals are required to complete PC-01 submission using the Inpatient Web-Based Measures data collection tool, through the [Hospital Quality Reporting Secure Portal](#).

**PLEASE NOTE:** Hospitals that do not deliver babies may file an [IPPS Measure Exception Form](#). Otherwise, hospitals that do not deliver babies must enter a zero (0) for each of the data entry fields for each discharge quarter prior to the submission deadline.
