What is the Public Reporting data preview?

Starting today, hospitals have 30 days to review the data that will be publicly reported on the [Care Compare website](#) on Medicare.gov in July 2021. The Compare tool on Medicare.gov is where Medicare beneficiaries and the public can review quality measure data for participating hospitals and facilities.

When can hospitals see their preview data?

Now through June 3, 2021, on the Hospital Quality Reporting page on *QualityNet* (<https://hqr.cms.gov/hqrng/login>), hospitals can preview the data that will appear on the July 2021 release. We encourage you to look at your information early in this preview period to conduct a thorough review.

How do hospitals see their preview data?

Access your Public Reporting preview data by following these steps:

1. Navigate to the Hospital Quality Reporting (HQR) page for *QualityNet* at <https://hqr.cms.gov/hqrng/login>.
2. Enter your Health Care Quality Information Systems (HCQIS) Access Roles and Profile (HARP) User ID and Password. Then, select **Login**.
3. You will be directed to the **Two-Factor Authorization page**. Select **Text** or **Email**. Select **Continue**.
4. Once you receive the code via **Text** or **Email**, enter it. Select **Continue**.
5. Read the Terms and Conditions statement. Select **Accept** to proceed. You will be directed to the **HQR Landing page**. **Note: If Cancel is selected, the program closes.**
6. On the **HQR Landing page**, hover over the Lock Menu on the left side.
7. Select **Program Reporting**.
8. From the drop-down menu, select **Public Reporting**.
9. The page will refresh, and the data will be available to preview.

To export the data displayed on the user interface (UI), select **Export Data** in the measure table. The exported measure data will be in PDF format for a user-friendly printed report.
