## **Data Submission Deadlines**

Reminder! Quarter 2 2022 (April 1—June 30, 2022) OP-38 (COVID-19 Vaccination Coverage Among Health Care Personnel) measure data are due by 11:59 p.m. Pacific Time (PT), November 15, 2022, on the National Healthcare Safety Network (NHSN) website.

The clinical data submission deadline is **11:59 p.m. PT, February 1, 2023,** for Quarter 3 2023 (July 1–September 30, 2022). Submission of Hospital OQR Program Population and Sampling data is voluntary.

# Facility-Specific Reports (FSRs) This Spring

Hospitals will be able to view their FSRs for Outpatient Imaging Efficiency (OIE) measures in the <u>Hospital Quality Reporting</u> (<u>HQR</u>) system this spring. This report includes patient episode information, scores, state results, and national results for each OIE measure (OP-8, OP-10, OP-13, and OP-39) for imaging studies performed from July 1, 2021-to June 30, 2022.

## **OP-23 Abstraction Guidance**

**Situation**: The status for OP-23\* data element *Last Known Well* equals "Yes" (Y) but the *Date Last Known Well* or *Time Last Known Well* is "Unable to be Determined" (UTD).

Guidance: It is important that abstractors follow the Notes for Abstraction in the <u>Data Dictionary</u> when selecting a "Yes" or "No" value for the *Last Known Well* data element. Only select a value of "Yes" if **both** the *Date Last Known Well* and a *Time Last Known Well* are documented in the medical record.

If "Yes" is selected for the *Last Known Well* data element, and either the *Date Last Known Well* or *Time Last Known Well* data elements are UTD, then the case will fall into the measure's denominator and negatively impact the facility's score.

If abstractors appropriately selected "No," due to an unknown **Date Last Known Well** or **Time Last Known Well**, then the case is excluded from the measure and has no impact on the facility's score.
