Hospitals participating in the Prospective Payment System (PPS)-Exempt Cancer Hospital Quality Reporting (PCHQR) Program have a deadline of 11:59 p.m. Pacific Time (PT) on **Monday, May 15, 2023**, to submit data for the healthcare-associated infection (HAI), Influenza Vaccination Coverage Among Healthcare Personnel (HCP), and COVID-19 Vaccination Coverage Among HCP measures.

Please enter your data into the National Healthcare Safety Network (NHSN) for the measures listed below. The data will be submitted via the Centers for Disease Control and Prevention (CDC) to the Centers for Medicare & Medicaid Services (CMS).

**Important Note:** In NHSN, a week belongs to the month in which the week ends. NHSN will not send a hospital’s Quarter (Q)4 2022 COVID-19 HCP measure data to CMS unless there is at least one week of data that ends in October, one week of data that ends in November, and one week of data that ends in December.

Please ensure that your data for the submission period are entered into the NHSN system prior to the submission deadline of 11:59 p.m. PT on **Monday, May 15, 2023**. Participants may run their
