Preview data will be available to participating Prospective Payment System (PPS)-Exempt Cancer Hospitals (PCHs) via the Hospital Quality Reporting (HQR) page on QualityNet at <https://hqr.cms.gov/hqrng/login> from **July 14–August 13, 2021**.

Access Preview Data

1. Navigate to the Hospital Quality Reporting (HQR) page on QualityNet at <https://hqr.cms.gov/hqrng/login>.
2. Enter your Health Care Quality Information Systems (HCQIS) Access Roles and Profile (HARP) User ID and Password. Then, select **Login**.
3. You will be directed to the **Two-Factor Authorization page**. Select **Text** or **Email**. Select **Continue**.
4. Once you receive the code via **Text** or **Email**, enter it. Select **Continue**.
5. Read the Terms and Conditions statement. Select **Accept** to proceed. You will be directed to the HQR Landing page. **Note: If Cancel is selected, the program closes.**
6. On the **HQR Landing** page, hover over the Lock Menu on the left side.
7. Select **Program Reporting**.
8. From the drop-down menu, select **Public Reporting**.
9. The page will refresh, and the data will be available to preview.
