Access Preview Data

- 1. Navigate to the HQR page on QualityNet at <u>https://hqr.cms.gov/hqrng/login</u>.
- 2. Enter your Health Care Quality Information Systems (HCQIS) Access Roles and Profile (HARP) User ID and Password. Then, select **Login**.
- 3. You will see the **Two-Factor** Authorization page. Select **Text** or **Email.** Select **Continue**.
- 4. Once you receive the code via **Text** or **Email**, enter it. Select **Continue**.
- Read the Terms and Conditions statement. Select Accept to proceed. You will see the HQR Landing page. (If you select Cancel, the program closes.)
- 6. On the **HQR Landing** page, hover over the Lock Menu on the left side.
- 7. Select Program Reporting.
- 8. From the drop-down menu, select **Public Reporting.**
- 9. The page will refresh, and the data will be available to preview.
