Subject: Reporting Exceptions Granted Due to Hurricane Ida

The Centers for Medicare & Medicaid Services (CMS) is granting exceptions¹ under certain Medicare quality reporting and value-based purchasing programs located in areas affected by Hurricane Ida to assist you while you direct your resources toward caring for patients and repairing structural damages to facilities.

Health and Human Services <u>Secretary Xavier Becerra declared Public Health Emergencies</u> (<u>PHEs</u>) for Louisiana, Mississippi, New York, and New Jersey. Affected counties designated by the Federal Emergency Management Agency (FEMA) under Hurricane Ida are located under sections Public Assistance PA-A and PA-B at each disaster declaration webpage:

- Louisiana Hurricane Ida (4611-DR-LA)
- Mississippi Hurricane Ida (3569-EM-MS)
- New Jersey Remnants of Hurricane Ida (4614-DR-NJ)
- New York Remnants of Hurricane Ida (4615-DR-NY)

If FEMA expands the current emergency disaster declarations to include additional counties, the website pages above will be updated to reflect the newly designated counties.

This exception is for acute care hospitals, ambulatory surgical centers (ASCs), Prospective Payment System (PPS)-exempt Cancer Hospitals (PCHs), inpatient psychiatric facilities (IPFs), inpatient rehabilitation facilities (IRFs), Long-Term Care Hospitals (LTCHs), and skilled nursing facilities (SNFs) and affects the following programs and reporting periods:

End-Stage Renal Disease Quality Incentive Program (ESRD QIP)

Dialysis facilities should note that CMS has not issued exceptions for ESRD QIP to address the impact of the Louisiana Hurricane Ida. Impacted dialysis facilities should submit ECE requests according to the process and form found on www.qualitynet.cms.gov Forms should be submitted to esrdqip@cms.hhs.gov within 90 days of the event.

Extraordinary Circumstances Exceptions (ECE)

Providers located <u>outside</u> the counties listed in the FEMA disaster declaration are not covered by this communication, but they may request an exception to the reporting requirements under one or more Medicare quality reporting or value-based purchasing programs they participate in using the applicable ECE procedure for the respective program(s). In addition, providers located within a county listed in the FEMA disaster declaration who seek an exception for a reporting requirement not covered by this communication may request an individual exception using the applicable ECE procedure for the respective program(s). CMS will assess each extraordinary circumstances exception request on a case-by-case basis.

Please be aware of the potential impact to reporting requirements and payment programs when deciding whether or not to report data included in the exceptions. If data is submitted, it may be publicly reported or used in scoring.

Please refer to the individual ECE request process and form specific to the program for additional information.
