Now through November 18, 2021, your hospital's preview data for the January 2022 Public Reporting release are available through the **Preview User Interface (UI)** on the Hospital Quality Reporting (HQR) page on <u>QualityNet</u>. You are encouraged to access data early in the preview period to conduct a thorough review.

Access your Public Reporting preview data by following these steps:

- 1. Navigate to the HQR page on QualityNet at https://hqr.cms.gov/hqrng/login.
- 2. Enter your HARP User ID and Password. Then, select **Login**.
- 3. You will see the **Two-Factor Authorization page**. Select **Text** or **Email.** Select **Continue** to proceed.
- 4. Once you receive the code via **Text** or **Email**, enter it. Select **Continue** to proceed.
- 5. Read the Terms and Conditions statement. Select **Accept** to proceed. You will see the **Landing** page. Note: If **Cancel** is selected, the program closes.
- 6. On the **Landing** page, hover over the Lock Menu on the left side.
- 7. Select **Program Reporting**.
- 8. From the drop-down menu, select **Public Reporting.**
- 9. The page will refresh, and the data will be available to preview.

To export the data displayed on the UI, select **Export Data** in the measure table. The exported measure data will be in PDF format for a user-friendly printed report.
