- 2. Enter your Health Care Quality Information Systems (HCQIS) Access Roles and Profile (HARP) User ID and Password. Then, select **Login**.
- 3. You will see the Two-Factor
 Authorization page. Select Text or
 Email. Select Continue.
- Enter the code you received and select Continue.
- Read the Terms and Conditions statement. Select Accept to proceed. You will see the HQR Landing page. Note: If Cancel is selected, the program closes.
- 6. On the **HQR Landing** page, hover over the Lock Menu on the left side.
- 7. Select Program Reporting.
- 8. From the drop-down menu, select **Public Reporting.**
- 9. The page will refresh, and the data will be available to preview.

Timely and Effective Care Measures Emergency Department Measures

- OP-18b, OP-18c, and OP-23 aggregate rates include Q4 2020 through Q3 2021 encounters.
- OP-18b and OP-18c display the state and national average minutes for hospitals that fall in the Low, Medium, High, Very High, and Overall Emergency Department Volume (EDV) categories.
- OP-18c measure data will only be included in the downloadable database.
