Preview data will be available to participating inpatient psychiatric facilities via the *Hospital Quality Reporting Secure Portal* **May 3 through June 1, 2023**.

Access Preview Data

1. Navigate to the Hospital Quality Reporting (HQR) page:
<https://hqr.cms.gov/hqrmg/login>
2. Enter your Health Care Quality Information Systems (HCQIS) Access Roles and Profile (HARP) User ID and Password. By logging in, you agree to the terms and conditions. Select **Log in**.
3. You will see the **Two-Factor Authorization** page. Select **Text** or **Email**. Then, select **Next**.
4. Enter the code you received and select **Next**.
5. On the **HQR landing** page, hover over the Lock Menu on the left side.
6. Select **Program Reporting**.
7. From the drop-down menu, select **Public Reporting**.
8. The page will refresh, and the data will be available to preview.
