Summer is one of our favorite seasons; it's full of opportunities for quality time and your data reporting activities to shine! Check out these essentials to make your summer data submission requirements a breeze:

- Prepare for summer: Submit ASC-20* measure data via the Centers for Disease Control and Prevention's (CDC) National Healthcare Safety Network (NHSN) system Quarter 1 2023 data are due on or before August 15, 2023.
 - Make sure you have an active Secure Access Management System (SAMS) account to access this portal and log in once every 60 days to keep your account active!
 - Make any needed updates to your email in the NHSN system first, then update SAMS to avoid being locked out of your account!
 - Consider having more than one registered Security Official in the <u>Hospital Quality</u>

 <u>Reporting (HQR)</u> system and a Facility Administrator in the NHSN system to ensure data can be submitted!
 - Collect and submit data for at least one self-selected week of each month in the quarter by the deadline. Ensure the week you are reporting ends in the month you are intending to report.
- Grab a lifeline: Visit the <u>Quality Reporting Center</u> website, where you can verify your submissions using the <u>Data Dashboard/ASC Lookup Tool</u>. Shore up your facility using the <u>Successful Reporting Guide</u>, your key to smooth sailing!
- Engage in some summer learning: Visit the Ambulatory Surgical Center pages of the QualityNet website to learn about tools and resources for successful summer submissions.
 - Review the 2023 ASCQR Program Specifications Manual to understand the reported data.
 - Review the four new web-based <u>measures</u> for the calendar year (CY) 2023 reporting period/2025 payment determination. Report ASC-1, ASC-2, ASC-3, and ASC-4* via the HQR system.

Keep these summer essentials handy and you will have it made in the shade all year long!



*ASC-1: Patient Burn; ASC-2: Patient Fall; ASC-3: Wrong Site, Wrong Side, Wrong Patient, Wrong Procedure, Wrong Implant; ASC-4: All-Cause Hospital Transfer/Admission; and ASC-20: COVID-19 Vaccination Coverage Among Healthcare Personnel (HCP)
