On or before the submission deadline	<p><b><u>STEP 2: Report COVID HCP measure data to NHSN.</u></b></p> <p>1. Visit <a href="https://sams.cdc.gov">https://sams.cdc.gov</a>. Enter the SAMS username, password, and grid card numbers.</p> <ul style="list-style-type: none"> <li>• Log into SAMS to access NHSN reporting.</li> </ul>	<input type="checkbox"/>
	<p>2. From the NHSN landing page, select the HPS component and facility ID from the drop-down menu.</p> <ul style="list-style-type: none"> <li>• Select Submit.</li> </ul>	<input type="checkbox"/>
	<p>3. Complete the <u>COVID-19 Weekly Vaccination Summary Data</u> form.</p> <ul style="list-style-type: none"> <li>• Click the yellow COVID-19 Vac box to enter COVID HCP measure data for a specific week.</li> </ul>	<input type="checkbox"/>
	<p>4. Enter COVID HCP Measure Data on the Healthcare Personnel COVID-19 Vaccination Cumulative Summary for Non-Long-Term Care Facilities form.</p> <ul style="list-style-type: none"> <li>• Enter COVID HCP measure data in all required data fields, indicated by red asterisks. Enter “0” if no HCP are reported for a required field.</li> <li>• Click Save at the bottom of your screen to save the record.</li> <li>• A message will appear indicating that your data have been saved.</li> <li>• Once data are entered as saved in NHSN, the yellow tab in the calendar view will appear green instead of yellow.</li> </ul>	<input type="checkbox"/>
	<p>5. Edit COVID HCP Measure Summary Data.</p> <ul style="list-style-type: none"> <li>• Click on the week to edit data. <ul style="list-style-type: none"> <li>○ After editing data, please click the Save button at the bottom of your data entry screen.</li> <li>○ Date Last Modified shows when the data were last entered and saved. Create Date indicates when the data were first entered and saved.</li> </ul> </li> <li>• Click Save to save updated data. A message confirming data were saved should appear at the top of the screen.</li> </ul>	<input type="checkbox"/>
<p><b>Note:</b> While navigating NHSN, use the NHSN buttons and not the web browser buttons. Data submitted correctly in NHSN will be transmitted from the CDC to CMS.
