# **Preview User Interface (UI) Access**

### **Preview Period**

Preview data are available to participating inpatient facilities **January 24–February 22**, **2024**, via the *Hospital Quality Reporting* (HQR) Secure Portal.

### **Access Preview Data**

- 1. Navigate to the HQR page: https://hqr.cms.gov/hqrng/login
- Enter your Health Care Quality
  Information Systems Access Roles and
  Profile User ID and Password. By logging
  in, you agree to the terms and conditions.
  Select Log In.
- The Two-Factor Authorization page appears. Select Text or Email. Select Next.
- 4. Enter the code you received. Then, select **Next**.
- 5. On the **HQR landing** page, hover over **Lock Menu** on the left side.
- 6. Select **Program Reporting**.
- 7. From the drop-down menu, select **Public Reporting.**
- 8. The page will refresh, and the preview data will be available.

# Hospital Consumer Assessment of Healthcare Providers and Systems (HCAHPS) Survey

- Results reflect Q3 2022–Q2 2023 discharges.
- You can preview individual questions from the HCAHPS composite measures in the downloadable database in the Provider Data Catalog (PDC); they are not displayed on Care Compare.
- HCAHPS scores based on fewer than 25 completed surveys will not appear on <u>Care Compare</u>.

### **Timely and Effective Care Measures**

- Influenza Vaccination Coverage Among Healthcare Personnel (HCP) displays 2022– 2023 flu season data (Q4 2022–Q1 2023).
- COVID-19 Vaccination Coverage Among HCP displays the most recent quarter (Q2 2023).
- SEP-1 and PC-01 measure results include Q3 2022–Q2 2023 data. (SEP-1 3-hour and 6-hour bundle data are included on PDC.)
- Electronic Clinical Quality Measures (eCQMs) for VTE-1, VTE-2, STK-02, STK-03, STK-05, STK-06, PC-05, ED-2, and Safe Use of Opioids display data submitted via electronic health records for calendar year 2022.

### Structural Measure

The Maternal Morbidity Structural Measure displays Q1 2022–Q4 2022 provider responses.

### **Complication and Deaths**

- The 30-Day Death Rate measure results reflect Q3 2019–Dec 1, 2019 and Q3 2020–Q2 2022. CMS Patient Safety Indicator measure updated results reflect Q3 2020–Q2 2022 discharges.
- Healthcare-associated Infection measure rates reflect Q3 2022–Q2 2023.
- Surgical complications rates reflect Q2 2019–Dec 1, 2019 and Q3 2020–Q1 2022 discharges.

### **Unplanned Hospital Visits**

- Condition-specific readmission rates reflect Q3 2019–Q4 2019 and Q3 2020– Q2 2022 discharges.
- Procedure-specific readmission rates reflect Q3 2019–Dec 1, 2019 and Q3 2020–Q2 2022 discharges.
- Hospital-wide readmission rates reflect Q3 2021 and Q2 2022 discharges.
- Excess Days in Acute Care measure results reflect Q3 2019–Dec 1, 2019 and Q3 2020–Q2 2022 discharges.

# Payment and Value of Care

- Acute myocardial infarction, heart failure, and pneumonia payment measure results reflect Q3 2019–Dec 1, 2019, and Q3 2020–Q2 2022 discharges.
- 90-day hip/knee payment measure results reflect Q2 2019–Oct 2, 2019, and Q3 2020– Q1 2022 discharges.
- Medicare Spending per Beneficiary measure performance scores display for Q1 2022–Q4 2022 discharges.
