The Dashboard displays open submission periods, deadlines, and upcoming submission periods, including when each period opens and closes. 2. Select Program Reporting from the navigation panel on the left side of the screen to verify your data submissions. 3. Select Submission Requirements from the dropdown menu, then select the Submission Requirements Dashboard navigation card. Submission Requirements Dashboard and Reports The Submission Requirements dashboard allows you to review program requirements and submission status and export reports. 1. Under Select a Program, select IQR. This opens the program’s Submission Requirements page. 2. From the Fiscal Year dropdown menu on the right side of the screen, select FY 2028. This view shows the current submission status for measures and program requirements; it does not confirm that a facility is eligible or has met all requirements. 3. To expand a section and view its contents, select the down arrow to the right of the section title. Each section provides details by discharge quarter, reporting period, performance period, or year. Expand and review each section to confirm data submission for each measure before exporting the information on this page. 4. To meet Q2 2026 IQR requirements, the following items should display a rate, met, and/or as submitted: a. Population and Sampling b. Chart-abstracted SEP-1 c. HAI CAUTI-Onc and CLABSI-Onc d. 	Performance Reports Performance reports allow facilities to review submitted quality measures, track clinical metrics in real time, validate data, and compare performance with state and national benchmarks. 1. From the navigation menu on the left side of the screen, select Program Reporting from the menu. 2. Select Performance Reports. You can now select the Performance Report Dashboard navigation card and continue to the next screen. 3. Under Select a Program, select the IQR navigation card. This brings you to the program's Performance Report page. 4. From the Fiscal Year dropdown menu on the right side of the screen, select 2028. Note: State and national rates displayed on the page are updated continuously while the submission period remains open. Each section provides facility, state, and national details by quarter, reporting period, performance period, or year. Use this dashboard to verify submissions, validate data, and compare facility results with state and national benchmarks. 5. To expand each section and view its contents, select the down arrow to the right of the section title. Please expand each individual section and review your data. 6. To export the information on this page, go to the Export button at the top right of the page, then select PDF or CSV to download.
