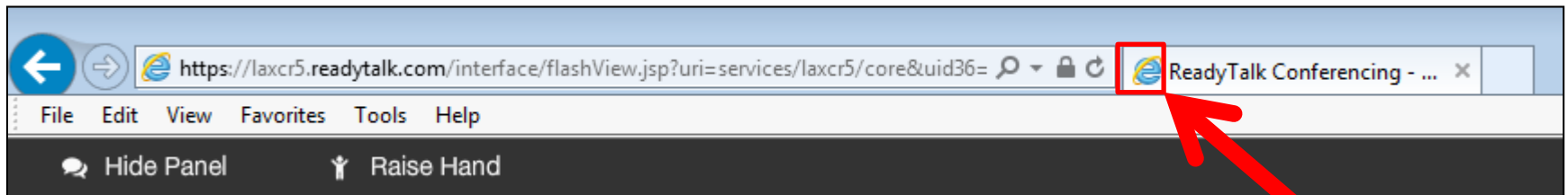

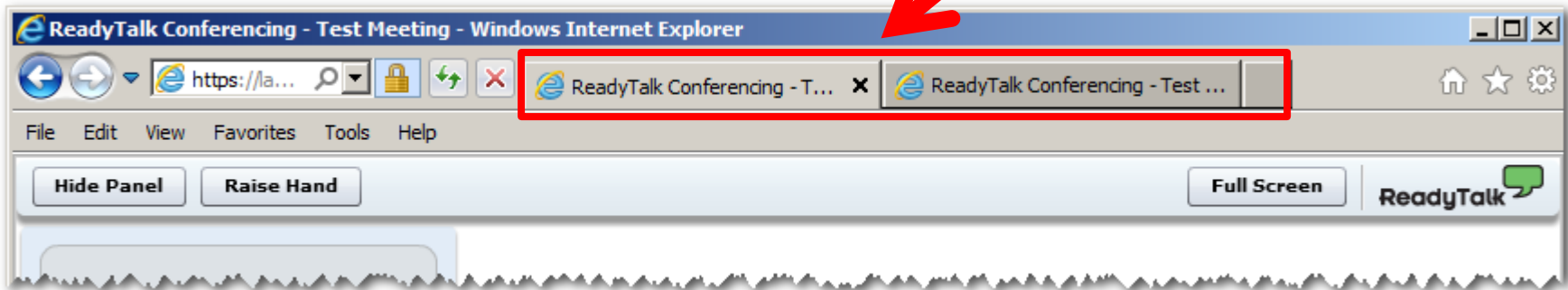

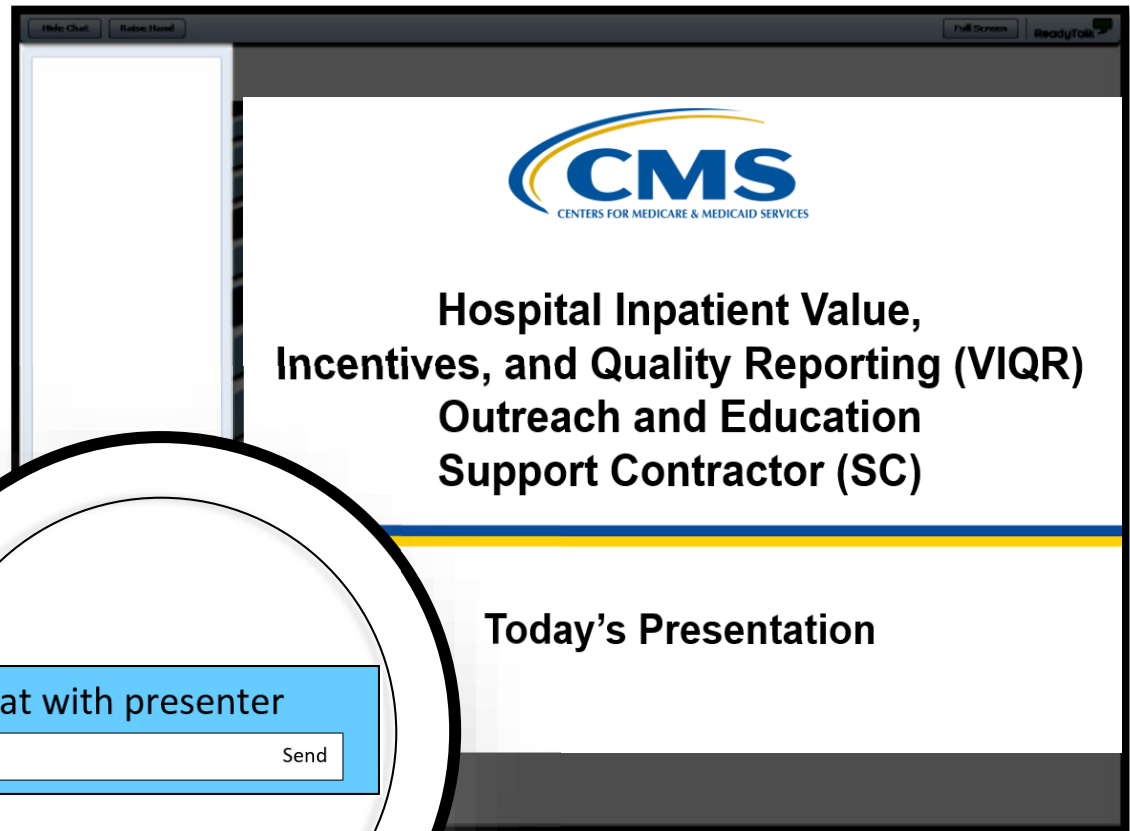
- Hear a bad echo on the call?

Inpatient Psychiatric Facility Quality Reporting (IPFQR) Program Overview

The Inpatient Psychiatric Facility Quality Reporting (IPFQR) program was developed as mandated by section 1886(s)(4) of the Social Security Act, as added and amended by Sections 3401(f) and 10322(a) of the Affordable Care Act (Pub.L. 111-148).

The IPFQR pay-for-reporting program is intended to equip consumers with quality of care information to make more informed decisions about healthcare options. It is also intended to encourage hospitals and clinicians to improve the quality of inpatient care provided to beneficiaries by, first, ensuring that providers are aware of and reporting on best practices for their respective facilities and type of care.

To meet the IPFQR program requirement, Inpatient Psychiatric Facilities (IPFs) are required to submit all quality measures in the form, manner, and time as specified by the Secretary, to the Centers for Medicare & Medicaid Services (CMS), beginning with Fiscal Year (FY) 2014 payment determination year and subsequent fiscal years. Because this is a pay-for-reporting program, eligible facilities will be subject to payment reduction for non-participation. Eligible IPFs that do not participate in the IPFQR program in a fiscal year or do not meet all of the reporting requirements will receive a 2.0 percentage point reduction of their annual update to their standard federal rate for that year. The reduction is non-cumulative across payment years.

Data collection

CMS collects annual, aggregate measure and non-measure data for the IPFQR Program as described in Section 2: Measure Details of the IPFQR Program Manual, which is located on the [IPF Resources](#) page.

Data submission

Participating facilities are **required** to submit their aggregate data for the required measures and acknowledge that all information submitted for the Inpatient Psychiatric Facility Quality Reporting Program is complete and accurate to the best of their knowledge at the time of submission. The measure data, non-measure data, and Data Accuracy and Completeness Acknowledgement (DACA) are submitted via the secure online CMS Web-based tool accessible through the QualityNet Secure Portal annually during the reporting period.

Data Accuracy and Completeness Acknowledgement (DACA)

Following the submission of the data, facilities acknowledge all the information that it submitted as required by the IPFQR program is complete and accurate to the best of its knowledge by the submission deadline of August 15, prior to the respective payment determination year.

Use of Vendors

A third-party vendor may submit data on a participant's behalf if previously authorized by the facility. The facility must complete the online authorization process accessible from the QualityNet Secure Portal. However, the facility is responsible for the data and the submission of the DACA.

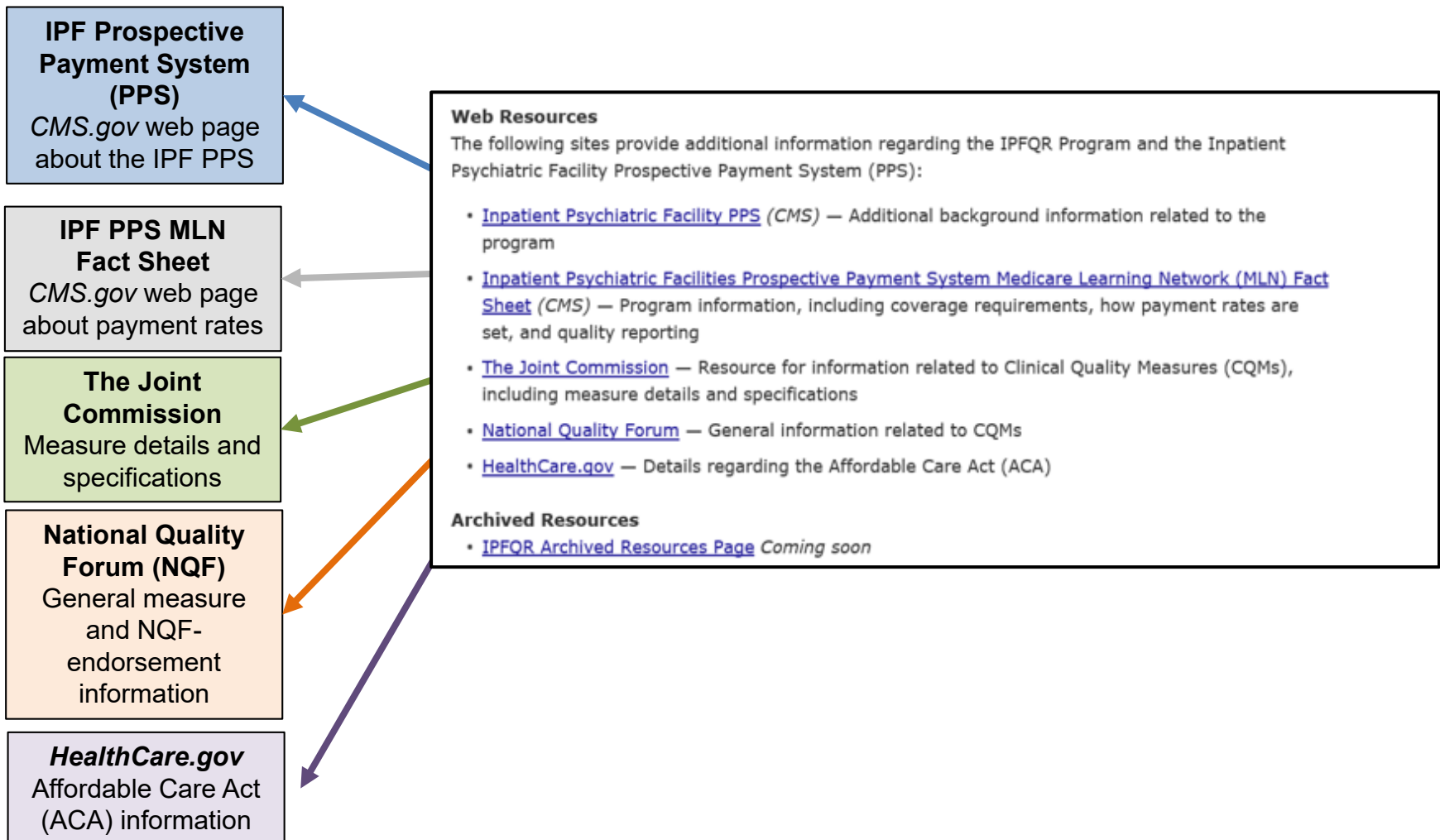

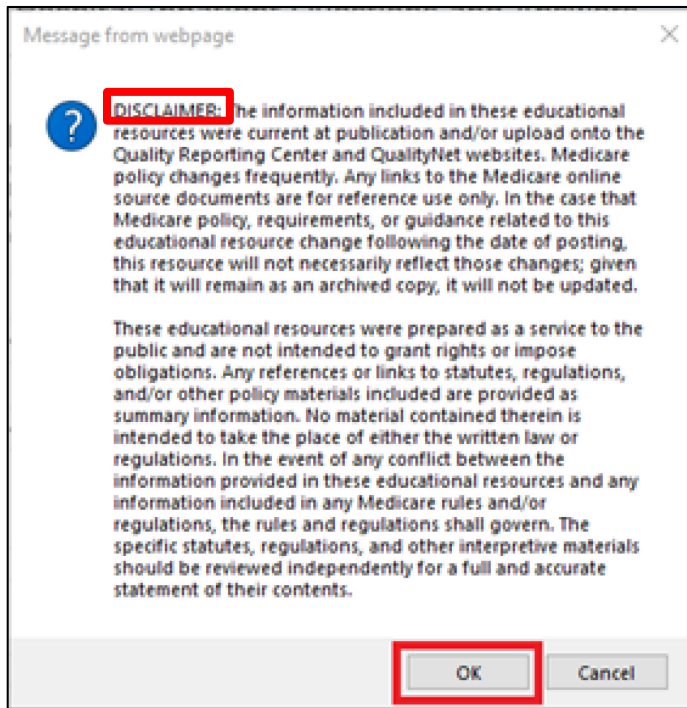

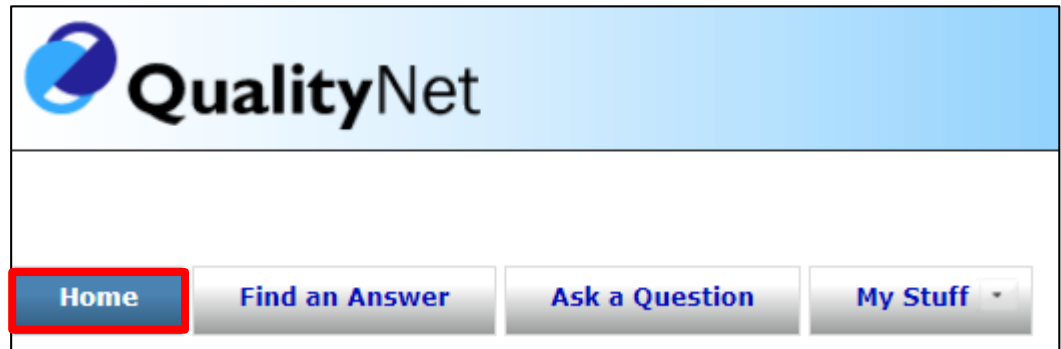

Examples of appropriate documentation are provided below for your reference:

Example 1 - Patient was brought in voluntarily by the police for assessment after the family called for assistance because they have become increasingly concerned about the patients' well-being. The police report stated that the patient had lost her job and was experiencing recurring episodes of hopelessness. The report also stated the patient had been talking about suicide in the recent past to family and friends, making statements like "I don't want to be alive, I am going to kill myself." Family members are not sure if she has intent with a plan or a means to complete a plan.

Example 2 - Patient came in under a Baker Act after exhibiting paranoid and delusional behaviors. He repeatedly told neighbors the FBI is after him and locked himself in his house. Family confirmed to police that he stopped taking his medications over a week ago, and missed his last monthly appointment for his shot. Police were called when neighbors noticed he had boarded up his ground-level windows from the inside.

The Centers for Medicare & Medicaid Services (CMS) offers a process for participating Inpatient Psychiatric Facilities (IPFs) to request and for CMS to grant extensions or exceptions with respect to the reporting of required quality data when there are extraordinary circumstances beyond the control of the facility.

In the event of such circumstances, an [Extraordinary Circumstances Exceptions Request Form](#) (PDF, 100 KB), with **all** required sections completed must be submitted. The facility may request consideration for an extension or exception of the requirement to submit quality data for one or more quarters. The form must be signed by the IPF's Chief Executive Officer (CEO) or designee and submitted **within calendar days of the date that the extraordinary circumstances occurred**.

Note: This process does not preclude CMS from granting exemptions or extensions to facilities when it is determined that an extraordinary circumstance, such as an act of nature, affects an entire region or locale. If CMS makes the determination to grant an exemption or extension to facilities in a region or locale, CMS will communicate this decision to facilities, vendors, and Quality Innovation Network-Quality Improvement Organizations (QIN-QIOs) through routine communication channels, including but not limited to issuing memos, emails and notices on *QualityNet*.

When a facility is dissatisfied with the result of a CMS reconsideration, the facility may file a claim under 42 CFR Part 405, Subpart R (a Provider Reimbursement Review Board [PRRB] appeal). Details are available on the [PRRB Review Instructions](#) page. **An appeal can be filed with the PRRB only after the facility has submitted a request for reconsideration and received an adverse decision on the request.**

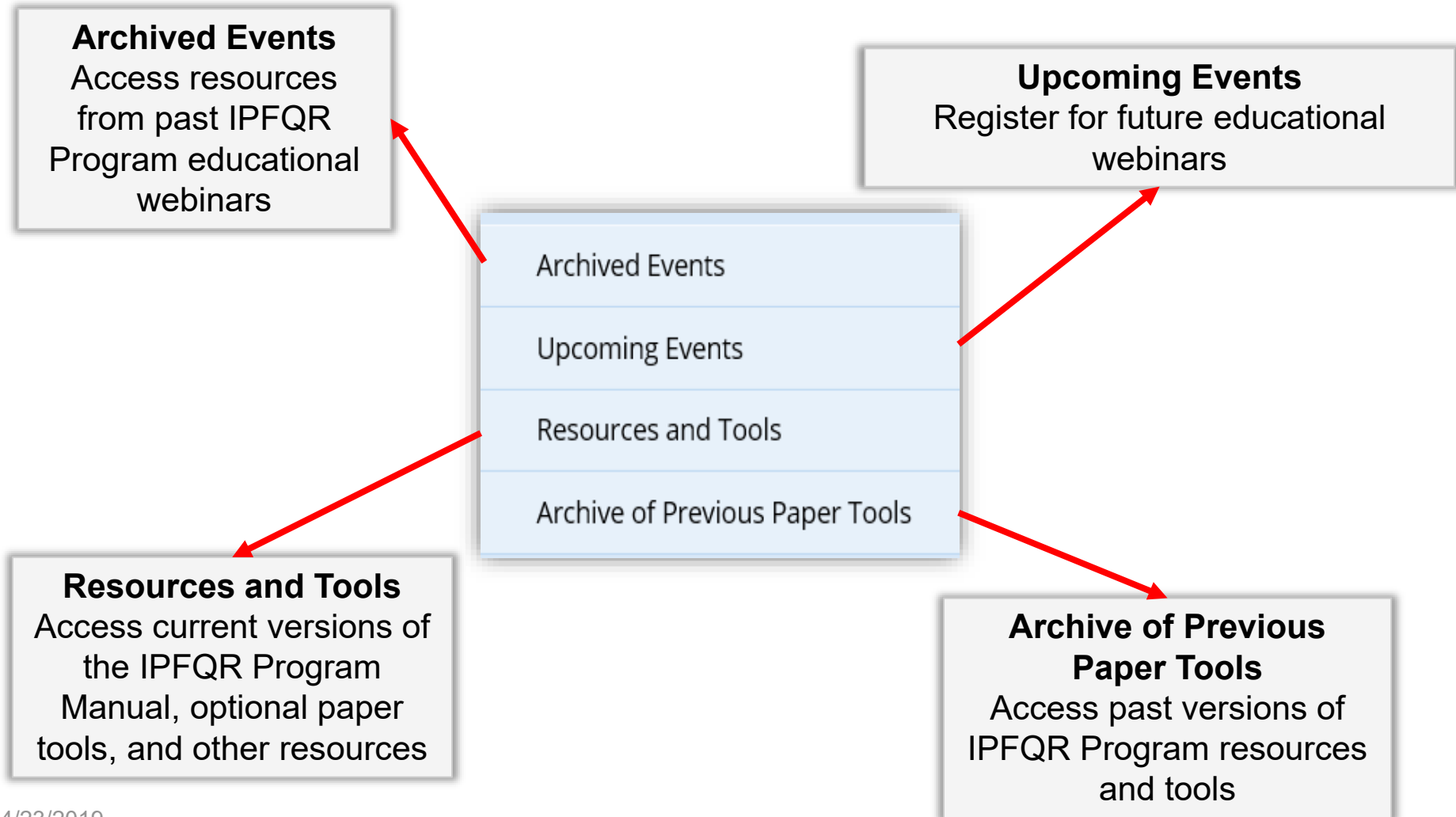
Overview

The Inpatient Psychiatric Facility Quality Reporting (IPFQR) program was developed as mandated by section 1886(s)(4) of the Social Security Act, as added and amended by Sections 3401(f) and 10322(a) of the Affordable Care Act (Pub.L. 111-148).

The IPFQR pay-for-reporting program is intended to equip consumers with quality of care information to make more informed decisions about healthcare options. It is also intended to encourage hospitals and clinicians to improve the quality of inpatient care provided to beneficiaries by, first, ensuring that providers are aware of and reporting on best practices for their respective facilities and type of care.

To meet the IPFQR program requirement, Inpatient Psychiatric Facilities (IPFs) are required to submit all quality measures in the form, manner, and time as specified by the Secretary, to the Centers for Medicare & Medicaid Services (CMS), beginning with Fiscal Year (FY) 2014 payment determination year and subsequent fiscal years. Because this is a pay-for-reporting program, eligible facilities will be subject to payment reduction for non-participation. Eligible IPFs that do not participate in the IPFQR program in a fiscal year or do not meet all of the reporting requirements will receive a 2.0 percentage point reduction of their annual update to their standard federal rate for that year. The reduction is non-cumulative across payment years.



IPFQR Program: Frequently Asked Questions

We recently experienced some staff turnover at our facility and have a couple of people in interim roles related to IPFQR Program data collection and reporting. What is the best way for me to notify CMS about this change?

You will need to complete and send back to us the Contact Change Form described earlier in this presentation. Be sure to check the appropriate box(es) to indicate the type of contact change that is reflected on the form so that we can update the system accordingly.

IPFQR Program: Frequently Asked Questions

How often is the IPFQR Program Manual updated to reflect changes within the IPFQR Program?

CMS updates the manual twice a year, usually in the spring and in the winter. The spring updates pertain to measure specification changes, where available from the measure stewards, and the winter update reflects changes to the IPFQR Program as described in the latest final rule for the IPFQR Program.

IPFQR Program: Frequently Asked Questions

I am able to log into the *QualityNet Secure Portal*, but I am unable to run reports or access the Secure File Transfer. Who do I contact to have the correct roles assigned to my account?

As the VIQR SC, we do not manage account creation nor role assignments in *QualityNet*. If you have access to the *QualityNet Secure Portal* but find that you are missing one or more of the roles needed to access reports from the “My Reports” menu and/or via the Secure File Transfer function, as described earlier in this presentation, you must contact the *QualityNet* Help Desk for assistance at (866) 288-8912 or qnetsupport@hcqis.org.

IPFQR Program: Frequently Asked Questions

My IPF's CBM data are not displayed in the IPF Participation and FSN reports. Where can I find that data?

The ISRs for the CBMs were provided for the first time in the latter part of 2018 and those reports contain detailed information about your IPF's CBM results and information at the state and national level. The overall rate for each of the CBMs will be available on the *Hospital Compare* website. Refer to Section 8 of the IPFQR Program Manual for information on how to locate and download measure data from the *Hospital Compare* webpage.




