Question 1: Would we have a separate login for the eCQI Resource Center than the Quality Payment Program (QPP) website?

That is correct. The eCQI Resource Center (https://ecqi.healthit.gov/) is a separate website from the QPP website (https://qpp.cms.gov/).

Question 2: Why are federal acute care hospitals excluded from the Hybrid Hospital-Wide Readmission (HWR) measure?

Federal acute care hospitals are not excluded; most are not in the Medicare fee-for-service payment program. The Hybrid HWR Measure is designed to extract the first captured set of vital signs and basic laboratory results obtained on Medicare fee-for-service (FFS) patients admitted to acute care short stay hospitals. Reporting of the Hybrid HWR Measure is applicable to subsection (d) hospitals.

Question 3: On the eCQI Resource Center, are the eCQM annual updates for the 2021 reporting period considered final at this point?

The 2021 eCQM specifications are considered final. The eCQMs for the 2021 submission/performance period for Eligible Hospitals and Critical Access Hospitals are final. The eCQMs for the 2021 submission/performance period for Eligible Clinicians and Eligible Professionals will be final when the Inpatient Prospective Payment System (IPPS)/Long-Term Care Hospital Prospective Payment System (LTCH PPS) final rule, Physician Fee Schedule final rule, QPP final rule, and Promoting Interoperability final rule are published.

Question 4: Can Ambulatory Surgical Centers use the eCQI Resource Center?

CMS uses the CMS.gov website for Ambulatory Surgical Center Quality Reporting (ASCQR) Program educational materials for outpatient care in hospitals and ambulatory surgical centers: https://www.cms.gov/Medicare/Quality-Initiatives-Patient-Assessment-Instruments/ASC-Quality-Reporting.

mentioned today?

A user account is not needed to view information contained in the eCQI Resource Center and the CMS Measures Inventory Tool (CMIT). You will need a user account to submit content or comment, such as a Proposed eCQM Concept, in the Measure Collaboration Workspace. Question 6: Does CMS automatically review National Committee for Quality

Assurance (NCQA) measure changes and update the measures here? For example, Avoidance of Antibiotic Treatment in Adults with Acute Bronchitis has changed to Avoidance of Antibiotic Treatment in All Patients with Acute Bronchitis in 2020 (to expand

the age range).

CMS reviews and updates all eCQMs used in the Merit-based Incentive Payment System (MBIPS) and Hospital IQR Program./ without regard for the measure owner.

Question 7: Do we need a username and password to use the CMS Measures **Inventory Tool (CMIT)?**

Use of CMIT does not require a username or password.
