Program Requirements	Submit data for at least four (4) of the eight (8) available eCQMs for one self-selected quarter of CY 2020 data (Q1, Q2, Q3, or Q4) during the same reporting period.	Dual Program Acceptance	Hospitals that successfully report on at least four (4) of eight (8) available eCQMs via the <i>QualityNet Secure Portal</i> will meet CQM requirements for the following: • Hospital IQR Program • Promoting Interoperability Program for Eligible Hospitals and Critical Access Hospitals
Reporting Deadline	March 1, 2021, by 11:59 p.m. Pacific Time (Deadline extended due to original deadline falling on a weekend and/or holiday.)

Use eCQM specifications published in the 	Successful Submission	Data must be submitted through the <i>QualityNet Secure Portal</i> as any combination of the following: • QRDA Category I files with patients meeting the initial patient population of the applicable measure(s) • Zero denominator declarations • Case threshold exemptions

System Availability	The Hospital Quality Reporting (HQR) system in the QualityNet Secure Portal will be open for the following: • Test File Submissions (Summer/Fall 2020) • Production File Submissions (Summer/Fall 2020)
		Tools Available	The Pre-Submission Validation Application (PSVA) tool (available as a download from the <i>QualityNet Secure Portal</i>) is highly recommended for hospitals to validate that the file structure is correct prior to test and production QRDA Category I file submissions.
Who Can Submit the Data	 The following entities can submit data: Hospitals with a QualityNet Secure Portal account and the EHR Data Upload Role assigned EHR vendors selected by the hospitals to submit data on their behalf Hospitals will need to log in to the QualityNet Secure Portal and use the Vendor Authorization screen to provide authorization to the vendor. EHR vendors will need to have a QualityNet Secure Portal account with the EHR Data Upload Role assigned.
