The Inpatient Psychiatric Facility Quality Reporting (IPFQR) Program has provided inpatient psychiatric facilities (IPFs) with Fiscal Year (FY) 2023 IPF-Specific Reports (ISRs) for claimsbased measures. ISRs allow IPFs to review the information that will be publicly reported in January 2023 for the *Follow-Up After Hospitalization for Mental Illness, Medication Continuation Following Inpatient Psychiatric Discharge*, and *Thirty-Day All-Cause Unplanned Readmission Following Psychiatric Hospitalization in an IPF* measures, which are calculated by the Centers for Medicare & Medicaid Services (CMS) using administrative claims data. ISRs also contain information that is not available to the public, such as beneficiary-level claims data and risk factors used to calculate the measures, to help inform quality improvement activities.

Your IPF's ISRs and user guides are available for download through the *Managed File Transfer* (*MFT*) *Dashboard*. Users will need to log in to the *MFT Dashboard* using their HARP username and password to access the mailbox. From there, click on Mail in the left-hand navigation pane and locate your ISR in the Inbox folder. The user guides include additional instructions on how to download and interpret your ISRs and information on how each measure was calculated for FY 2023 public reporting. CMS will host a webinar to review the ISR content and share tips for interpreting your facility's data. IPFQR Program Listserv subscribers will receive an email with registration information prior to this event.

Facilities are encouraged to review their ISRs and supporting documents for discrepancies or concerns regarding the data available for public reporting. Any discrepancies or concerns **must be submitted to the CCSQ Service Center by the end of the confidential review period on December 7, 2022**. The IPFQR Program confidential review period does **not** allow IPFs to submit corrections or add new claims to the data used to calculate the rates.
