Subject: NOTICE: IPFQR Program FY 2024 Submission Deadline Extension

The purpose of this email is to notify Inpatient Psychiatric Facility Quality Reporting (IPFQR) Program providers that the Centers for Medicare & Medicaid Services (CMS) has extended the submission deadline for fiscal year (FY) 2024 IPFQR Program requirements from August 15, 2023, to Friday, September 1, 2023, at 11:59 p.m. Pacific Time.

All eligible IPFQR Program providers must complete **all** requirements by September 1, 2023, to qualify for the full Inpatient Psychiatric Facility Prospective Payment System annual payment update. CMS encourages all participating facilities to submit data at least two days prior to the deadline to allow time to address any submission issues.

<u>Quarter (Q)1 2023 COVID-19 Vaccination Coverage Among Healthcare Personnel (COVID HCP) Measure</u>

The deadline extension **does not** impact the Quarter 1 2023 COVID HCP measure data submission deadline. IPFs must submit the Quarter 1 2023 COVID HCP measure data to the National Healthcare Safety Network (NHSN) **by August 15, 2023**.
