**Submission Reminder** 

By Wednesday, November 15, 2023, facilities participating in the Inpatient Psychiatric Facility Quality Reporting (IPFQR) Program must submit the COVID-19 Vaccination Coverage Among Healthcare Personnel (COVID HCP) measure data for the Quarter 2 2023 (April 1–June 30, 2023) reporting period. Providers must be enrolled with the National Healthcare Safety Network (NHSN) to submit measure data. IPFs already enrolled with the NHSN are advised to log in well in advance of the deadline to avoid potential access issues.

Failure to submit COVID HCP measure data may result in a 2-percentage point reduction in the fiscal year 2025 annual payment update (APU) from the Centers for Medicare & Medicaid Services (CMS). If you have not already done so, we strongly recommend that your IPF begin the enrollment process with the NHSN now. Quarterly deadlines for the COVID HCP measure data will also impact future payments.
