**Subject:** CMS Releases FY 2024 EOL Measure Confidential Reports

The confidential fiscal year (FY) 2024 End-of-Life (EOL) measure reports are now available for review. The FY 2024 performance period is July 1, 2021, through June 30, 2022. The reports can be downloaded in a CSV format via the *Hospital Quality Reporting (HQR) Secure Portal*.

To access the FY 2024 reports, please log into the *HQR Secure Portal* (<a href="https://hqr.cms.gov/hqrng/login">https://hqr.cms.gov/hqrng/login</a>) and select **Program Reporting** from the left-side navigation menu. Then, select the **Performance Reports** option. Select the **PCHQR** option in the Program dropdown. Then, select one of the EOL reports listed in the Report dropdown. In the Fiscal Year dropdown, select **2024**. Click the **Export CSV** button to download the selected report. Repeat these steps to download the other EOL report.

Please note that there are two EOL Facility-Specific Reports (FSRs) to review:

- The **EOL Measures Performance Report** documents your hospital's performance for all four EOL measures and provides the national performance of all Prospective Payment System (PPS)-Exempt Cancer Hospitals (PCHs) for comparison.
- The EOL Measures Patient Summary Report includes all the beneficiaries attributed to your hospital that were in the denominator for any of the measures, with indicators detailing whether a beneficiary was, or was not, included in each of the measures' numerators and denominators.
  Note: The Medical Record Number column has been added back to this report.

Questions regarding the EOL Measures Performance Report and EOL Measures Patient Summary Report can be submitted through the <u>QualityNet Question & Answer Tool</u>. Please select PCH – Cancer Hosp. Quality Reporting as the Program and Clinical Process/Oncology Care Measures (OCM) or Intermediate Clinical Outcome Measures as the Topic. To ensure proper handling of inquiries, please reference the hospital's CMS Certification Number (CCN).

The **EOL Measure Patient Summary Report** contains discharge-level data protected by the Health Insurance Portability and Accountability Act of 1996 (HIPAA).
