**Subject:** Overall Hospital Quality Star Rating Hospital-Specific Reports (HSRs)

Today, **May 15, 2025**, the Centers for Medicare & Medicaid Services (CMS) has made available, the July 2025 Overall Hospital Quality Star Rating Hospital-Specific Reports (HSRs) in the Hospital Quality Reporting (HQR) system. The July 2025 Overall Star Ratings were calculated using the measure data from the October 2024 refresh.

Hospitals have 30 days to review their reports before public reporting. The July 2025 preview period will occur from **May 15, 2025, through June 13, 2025**, for hospitals to preview their Overall Star Ratings data that will be publicly reported in July 2025. The preview period is **not** a Review and Corrections period, during which hospitals can resubmit corrected data.

For July 2025, the Measure Detail Overall Star Rating HSRs are now available to download in either PDF and/or CSV formats. These enhanced formats will include all the same information that was previously provided in the HSR Excel format. Please review the HSR User Guide for more information.

The PDF format will display the following hospital's results:

Under the performance information accordion, your hospital's Overall Star Rating, Hospital Summary Score and Peer Group which previously was provided on Table 1.

Under the Measure group score accordion, Number of measures reported, Number of potential measures within each group, Hospital's measure group weight, Standard measure group weight, Measure group score, Measure group national mean of scores, Measure group standard deviation across hospitals, Hospital's standardized measure group score and National group score, previously provided on Table 2.

Under each group, Measure scores accordion (Mortality, Readmission, Safety of Care, Patient Experience and Timely and Effective Care), Hospital's measure result, Measure performance category, Measure's national mean of scores, Measure's standard deviation across hospitals, Hospital's standardized measure score and Measure weight, previously provided on Table 3.

The CSV format can be exported and will display all unrounded values, whereas the PDF format will provide rounded values as seen previously.

The Hospital-Specific Report User Guide which will provide further explanation for results, measure reporting periods and links to resources on QualityNet Overall Star Ratings web pages will download with the CSV report.

You can access your Overall Star Rating Hospital-Specific Reports directly from the Hospital Quality Reporting (HQR) system.

Access your Hospital-Specific Report by following these steps:

1. Navigate to the Hospital Quality Reporting (HQR) page: <https://hqr.cms.gov/hqrng/login>
2. Enter your Health Care Quality Information Systems (HCQIS) Access Roles and Profile (HARP) User ID and Password. By logging in, you agree to the terms and conditions. Select **Log in**.
3. The **Two-Factor Authorization page** will appear. Select **Text** or **Email**. Select **Next**.
4. Enter the code you received. Then, select **Next**.
5. On the **HQR landing** page, hover over Lock Menu on the left side.
6. Select **Program Reporting**.
7. From the drop-down menu, select **Measure Details**.
8. On the Measure Detail Dashboard, select the **Measure Detail View**.
9. On the Measure Detail View, select **Overall Star Rating**.
10. Your Overall Star Rating Hospital-Specific Report will display.
11. You may export the PDF version by selecting Export, then choose PDF.
12. For full details of the HSR results, please Export the CSV (Performance Data) file.
13. Your Overall Star Rating Hospital-Specific Report (CSV) and User Guide will be downloaded in a zip file when exported.
