- Answer:** Please call our Help Desk. We can send the report via Secure File Transfer through QualityNet, if you have the appropriate access rights.
- Question:** Our billing company submitted the wrong Quality Data Codes (QDCs) on three of our claims. Is there any way to file an appeal to get those reversed?
- Answer:** Unfortunately, there is no process to file an appeal, and you cannot resubmit claims for the sole purpose of adding QDCs after the claim has been adjudicated.
- Question:** How do you run the Claims Detail Report?
- Answer:** You run this report on the secure side of QualityNet. You can call our call center at 866-800-8756, we will be glad to walk you through this process.

- Question:** Why would it say “no data found”?
- Answer:** There may be a few reasons why the report would reflect no data found. You may call our support help desk. Please have your facility’s National Provider Identifier (NPI) available so we can better assist you at 866-800-8756.
- Question:** If finalized, when do we stop abstracting for ASC-9 and -10?
- Answer:** If finalized for removal from the ASCQR Program, this would be for the CY 2021 Payment Determination and subsequent years. The last time you will report data for those measures will be May 15, 2019, using patient encounters of January 1 through December 31, 2018.
- Question:** I know that I have access to QualityNet. I'm not sure about Secure File Transfer (SFT).
- Answer:** Once you sign into the secure side of QualityNet, SFT will be at the top of the page if you have Security Administrator rights. Simply click on the Secure File Transfer icon.
- Question:** If we are no longer reporting the flu vaccination to NHSN, where would it be reported?
- Answer:** We can only speak for the requirements of this program. If ASC-8 is finalized for removal for this program, you may still have to report this data to other entities. Please check with your state and/or other programs to ensure you are complying with those requirements.
- Question:** Any idea why ASCs’ performance went down for ASC-10?
- Answer:** There are many reasons contributory to this. Keeping up with your data and monitoring your internal processes will assist your facility with better performance.
